

## **Declaration of Intent**

## On "Management with Integrity, Morality and Transparency" The Secondary Educational Service Area Office Phatthalung

According to the Constitution of the Kingdom of Thailand B.E. 2560 (2017) prioritizes on prevention and suppression of corruption and misconduct. Focus on anti-corruption to enhance good governance by integrated management to emphasized the process of prevention and suppression system of corruption and misconduct to be more effective to all sectors under the administration of the Secondary Educational Service Area Office Phatthalung. According to the National Strategic Plan on corruption prevention and suppression, phase 3 B.E. 2560 – 2564 (2017-2021), the Announcement of the Prime Minister Office on National Reform on corruption prevention and suppression made on 6<sup>th</sup> April, B.E.2561 (2018) and other relevant laws, it is deemed highly important and obligatory that the governmental sector management must be transparent, ethical and virtuous.

As the administrator of the Secondary Educational Service Area Office Phatthalung, I declare the intention of personnel administration in a governmental sector to the public which mentions that all sectors, both schools and offices will work with the benefits of the public by honesty, virtue, transparency, justice and effective management. Cooperate with all sectors to prevent, suppress corruption and misconduct of officers as all levels, including respond and facilitate the public as follows:

- 1. Implement all duties and tasks by performing the required steps under laws, regulations, principles, methods of operation strictly.
- 2. Strengthen moral, ethics and awareness in the management of the executives and officers in the organization to focus on the common interest, knowledge, understanding and ethics. The personnel of the Secondary Education Service Area Office Phatthalung aware of the adverse effects of corruption on their organization in particular unit and the country as a whole.
- 3. Totally refuse and not socially tolerate to any corruption-oriented behavior and corruption. With the sense of unacceptability and intolerance of corruption is widely practiced, it is optimistically expected that the personnel's sense of shame and dread of all sectors both in the office and the schools will be developed. As a result, they will not be engaged in corruption.

- 4. Develop a sense of shame and awareness of the adverse effects of corruption to a mass of students under the administration of the Secondary Educational Service Area Office Phatthalung.
  - 5. Formulate the guidelines of implement and cooperate activities which are:
- 5.1 Coordinate and cooperate to implement the national strategy on corruption prevention and suppression in phase 3 (2017 2021).
- 5.2 Strengthen all agencies and personnel concerned as the network to prevent and suppress the corruption among the Office of the Basic Education Commission, the educational service area office and its administrative schools.
- 5.3 Promote and provide knowledge on the national strategy on corruption prevention and suppression, phase 3, especially the guidelines to enhance virtues, and ethics for the personnel of the agencies concerned, school administrators, teachers and students. In addition, students' parents and the public are to participate in the anti-corruption activities and corruption prevention and suppression network.
- 5.4 Participate in providing knowledge and information on preventing corruption of the personnel in the agencies.
- 5.5 Cooperate in formulating indicators to evaluate virtues and transparency for the agencies under the administration of the Secondary Educational Service Area Office Phatthalung and implement throughout the guidelines.
- 5.6 Formulate the communicative channels to disseminate and publicize information.
- 5.7 Provide counseling, recommendations, supervision as well as evaluate the implementation throughout the plan.
- 5.8 Cooperate and implement any means available to prevent and suppress corruption of all types to the full extent of individuals' potential.
